Announcement by the Rector of the Cracow University of Economics of 24 August 2020

on the organisation of studies in the winter semester of the academic year 2020/2021, in connection with COVID-19 pandemic, in full-time and part-time studies of the first and second cycle, uniform Master's studies, and doctoral studies

Due to the current epidemiological situation, I announce the planned organization of studies in the winter semester of the academic year 2020/2021.

- 1. The teaching process will be carried out using three forms of education:
 - 1) **S:** Intramural (on-campus) education with elements of distance learning (online education) methods and techniques i.e. students participate in some of the classes at the University's campus throughout the entire semester.

As a rule, this form of education applies to students of the first year of the first-cycle studies, and students of the first year of the uniform Master's studies. This applies to both full-time and part-time studies, assuming that classes other than lectures and tutorials will be implemented on intramural basis (on the University campus), whereas classes in the form of lectures and tutorials will be conducted through the use of methods and techniques enabling synchronous education, carried out in accordance with the agreed schedule of classes.

2) **ZS**: Distance learning with elements of intramural education. The organization of the classes provides for the implementation of a few subjects with special requirements (e.g. laboratory classes) in the intramural form (on-campus).

This form of education generally applies to selected subjects, and it includes in particular:

- Laboratory classes in the fields of study/study majors at the Institute of Quality Sciences and Product Management;
- Items requiring the use of licensed software available only on campus;
- Field activities.
- 3) **Z:** Distance learning (online education).

This form of education concerns education in situations not covered by the forms indicated in points (1) and (2).

- 2. An Appendix to this Announcement specifies the form of organization of studies in particular Institutes, in relation to the fields of study/study majors that they provide, broken down into individual years of study.
- 3. Detailed guidelines regarding the form and requirements for conducting classes are determined by the Vice-Rector for Education and Student Affairs, after consulting the Directors of the Institutes, taking into account the current sanitary and epidemiological recommendations.
- 4. The arrangements referred to in the preceding point are made available to the academic community no later than 2 weeks before the beginning of the academic year 2020/2021.
- 5. In the event of a change in the level of epidemiological threat, the University authorities will make decisions regarding the CUE organizational units switching to the form of distance learning (online education) only.
- 6. The forms of education provided by all the Institutes, in all the years of study, will be adapted to the currently applicable regulations, including those resulting from generally applicable legal provisions.
